The Treasurer reviewed the Monthly Financials for the Board. He spoke on Alternative Ed Program enrollment figures through the end of September. He discussed the Agreed Upon Procedure process that would start on October 16, to certify the Actual Unit Cost Report on Mental Health and Drug and Alcohol Prevention Services provided during FY12. He stated that the Medicaid and Medicaid Match, now coming from Ohio Department of Job and Family Services, has started flowing to the ESC, as well as the "Contracted Levy dollars" from the Mental Health Recovery Board, for Mental Health Services being provided for the current Fiscal Year.

Superintendent's Report

The Superintendent discussed the "Third Grade Reading Guarantee" as established by Ohio Department of Education requiring teachers to obtain a "reading endorsement", to be another "unfunded mandate". He stated that he will be penning a letter to local legislators on behalf of Greene County School Districts voicing concerns. He discussed the renting of additional space to MVECA, as well as needed upgrades to MVECA space. He also discussed the ESC facilities and the future needs regarding roof and HVAC upgrades. He congratulated the Treasurer, and his office, on the recently awarded, "Auditor of State Award" for "clean and timely" financial reporting as determined by the Audit for Fiscal Year FY12.
