It was the lowest daily average in the last 8 program years. He also mentioned that the Academy/Outdoor Advantage "additional tuition", which is over and above the "contracted tuition" was higher than it has ever been in the same time period. He reviewed the FY2016 "Final Appropriations, Budget and Estimated Revenue" document for approval later in the meeting. He also reviewed the FY2017 Temporary Appropriations for approval later in the Meeting.
